

## 99.9 More FM – FREE MONEY MATCH AND WIN OFFICIAL RULES

1. HOW TO ENTER/HOW THE WINNERS ARE CHOSEN: NO PURCHASE NECESSARY; A PURCHASE WILL NOT IMPROVE CHANCES OF WINNING. To participate in this sweepstakes, starting Monday, September 10th, 2018, listeners can go to [www.999morefm.com](http://www.999morefm.com) to download a game board which they can use to play FREE MONEY MATCH AND WIN. Beginning Monday, September 10th, 2018 when listeners hear the on-air personality asking for the ninth (9th) caller at 8:20 a.m and 4:20 p.m., the first person to be the ninth (9th) caller who reaches the station by calling 320-253-6673, will play the game by guessing two game board positions (the game board will be labeled 1-40); if the caller matches two game board positions that feature the same dollar amount in each position, he/she will win the cash in those matching positions (For example, if the caller guesses Nos. 3 and 14 and those two positions each contain \$50, the caller wins \$50.) No prize will be awarded if the two numbers guessed by the caller do not contain the same amount of money. This sweepstakes will run weekdays from Monday, September 10, 2018, until Friday, October 12th, 2018.

2. PRIZE: There is a minimum amount of \$5.00 and a maximum amount of \$500 on the board each week. Each player will also receive a \$25 certificate good for service or parts at St. Cloud Toyota.
